VILLAGE OF HEISLER

TAX RATE BYLAW #495-16

A bylaw to authorize the rates of taxation to be levied against assessable property within the Village of Heisler for the 2016 tax year.

WHEREAS, the Village of Heisler has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on April 19, 2016 and,

WHEREAS, the estimated municipal revenues and transfers set out in the budget for the Village of Heisler for 2016 total **\$617,067.00**; and,

WHEREAS, the estimated municipal revenues and transfers from all sources other than taxation is estimated at **\$417,802.00**, and the balance of **\$199,265.00** is to be raised by municipal taxation; and,

WHEREAS, the requisitions are:

Alberta School Foundation Fund - Residential	\$17,407.26
Alberta School Foundation Fund - Non-Residential	\$4,926.74
Flagstaff Regional Housing Group (Seniors Foundation)	\$1,972.00

AND WHEREAS, the Council of the Village of Heisler is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and,

WHEREAS, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect of each class of property, subject to the Municipal Government Act, Chapter M26.1, Revised Statutes of Alberta, 2000; and,

WHEREAS, the assessed value of all property in the Village of Heisler as shown on the assessment roll is:

Residential	\$6,947,330
Non-Residential	\$1,354,820
Total Assessment	\$8 302 150

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Village of Heisler in the Province of Alberta enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Village of Heisler:
