FATHER KLER UPDATE:

A Council meeting with Father Kler, David Wolbeck, and Sheldon Steil was held on January 24, 2010. The purpose of the meeting was to clear up matter(s) that would either inhibit or prohibit the completion of the sale of subdivision as originally approved by the previous council. It was noted that both the Village and someone from the Church had previously signed the contract (indicating that, indeed, the property had been sold to the village) and everyone agreed to accept that contract as the one they would submit to the Church for approval.

Father Kler and David Wolbeck will present the site plan and signed agreement to the Church for approval and adoption, and then report back to the Village. It was noted that an agreement had been reached between the Village and Church that, because the Village gifted the land to the church some time ago, the Village was to pay all legal costs incurred by the church for this sale.
