<u>Heisler 2017 Celebration Committee – July 7-9 Celebration Event Requests and</u> <u>Correspondence</u>

- 5. That the village will accept a donation from the Celebration Committee for purchase of fireworks, the village will then reimburse the committee the GST that was paid.
- 6. Purchase t-shirts for event from Main Street Medley; approx. **\$1,200** *transfer funds from general reserves.* The \$1,200 is to be returned to the village, and the committee shall retain the profit.
- 7. Approve request that alcohol be sold on public property (Main Street) during event.
- 8. Provide inventory of 150 Heisler pins to be sold at souvenir table. Pins may be sold for whatever committee wishes to charge, as long initial cost funds are returned to the village (currently sold at \$3.00 each), along with any unsold pins.

• Provide oversight and testing of the SCADA improvements which will include changing the regional server into a backup system for each individual site and building in control mechanisms to allow for remote control of plants facilities.

It is further moved that Heisler Village Council does not approve the recommendation to agree to a five (5) year commitment to fund the position of a Regional Water/Waste Water Coordinator at a cost of \$150,000 per year.
