1. TITLE:

1.1 Snow Removal Policy

2. POLICY STATEMENT:

- 2.1 The Village of Heisler believes that to keep good order of the roadways found within the Village boundaries during the winter months, each roadway must be prioritized.**

3. PURPOSE:

- 3.1 To ensure the general public, employees and staff of the Village of Heisler know what roadways are priorities for snow removal, this policy will be enacted.**

4. SCOPE:

- 4.1 The scope of this policy includes but is not limited to the Public Works Department and the general public.**

5. OBJECTIVES:

- 5.1 The objective of this policy is to ensure that the ideas presented in the Purpose of this policy will be upheld.**

6. POLICY DETAILS:

- 6.1 After a snowfall and the roadways need to be plowed as shown through Bylaw 523-20 (The Snow Removal Bylaw), this policy must be consulted to outline what roadways are priorities.**

- 6.2 The top priority roadways are as follows:**

6.2.1 Fire Department Driveway

6.2.2 Manning Avenue

6.2.3 Sifton Street

6.2.4 Main Street

6.2.5 Stewart Street

6.2.6 Strom Street

6.3 The second priority roadways are as follows:

6.3.1 Haultain Avenue

6.3.2 Rutherford Avenue

6.3.3 Aberhart Avenue

6.3.4 Brownlee Street

6.3.5 Greenfield Street

6.3.6 Reid Street

6.4 The third priority roadways are as follows:

6.4.1 All Village Back Alleys

6.4.2 St. Martin's Church parking lot

6.4.2.1 Public Works must make efforts to ensure the lot is clear of snow for scheduled Sunday Mass.

6.4.3 Heisler Track Loading Facility

6.4.3.1 Public Works must clear the roadway, east and west approaches and parking lot.

6.4.4 Heisler Community Cultural Centre

6.4.4.1 Public Works must clear the snow from the parking lot at the rear of the building and the front sidewalk of the building.

6.4.5 Walking Trails

6.5 The Public Works department must follow the aforementioned priorities.

7. ROLES AND RESPONSIBILITIES:

- 7.1 It is the role of the Public Works Department of the Village of Heisler follow this policy and Bylaw 523-20 (The Snow Removal Bylaw) during the winter months.**
- 7.2 It is the responsibility of the Public Works Department to follow the aforementioned roadway priorities.**
- 7.3 It is the role of the Administration Department and the Heisler Village Council to make the general public aware of what roadways are priorities when an inquiry is made.**

8. MONITORING, EVALUATION AND REVIEW:

- 8.1 The monitoring, evaluation and review of this policy is the responsibility of the Administration Department of the Village of Heisler.**

9. DEFINITIONS AND ABBREVIATIONS:

- 9.1 All Definitions are subject to those found within the Municipal Government Act Revised Statutes of Alberta 2000 Chapter M-26.**
